

# TREVOR BURNS

## Family History, Public Profile, Affiliations, and Financial-Transparency Research

*A public-source research brief*

**Purpose and scope.** This report compiles public, attributable sources concerning Donald Trevor Burns (publicly referenced as Trevor Burns), including documented family context, publicly visible Rhema connections, education/employment and affiliation verification limits, and financial-transparency cautions. It is intentionally narrower than reports concerning public ministry officers because the reviewed public record does not establish Trevor Burns as an officer, employee, spokesperson, candidate, or public-facing ministry leader. Family relationship is not evidence of wrongdoing, compensation, authority, governance, knowledge, or responsibility for another person's conduct.

### Executive summary

The strongest public record identifies Trevor Burns as Donald Trevor Burns, the son of Don Burns and Rev. Denise Hagin Burns, and the older sibling of Wesley Burns. Historic Kenneth Hagin Ministries materials identify him as a great-grandson of Kenneth E. Hagin and Oretha Rooker Hagin. A 2001 ministry publication documents his birth and family dedication at Rhema Bible Church. A MaxPreps athlete profile also identifies Trevor Burns with Metro Christian High School in Tulsa, Oklahoma, and lists basketball and football participation. The available sources do not independently establish graduation, postsecondary education, an employment role, salary, ministry office, business ownership, political affiliation, travel reimbursement, or financial interest.

## Family history and relationship map

The publicly documented family relationship chain is as follows. The report uses relationship descriptions only for historical context and does not infer organizational responsibility from lineage.

Sibling	Wesley Burns	Official Rhema material and publicly indexed ministry sources identify Wesley Burns as the second son in the family; his public roles are separate from Trevor's record.

### Documented early public reference

A November 2001 issue of The Word of Faith reported that Donald Trevor Burns was born on March 22, 2001, and described a dedication at Rhema Bible Church on July 22, 2001. This report includes the historical reference because it is an official-publication source confirming the family relationship. It does not repeat unnecessary medical or other sensitive details from the article.

### Family and institutional context

Denise Hagin Burns is publicly listed by Rhema Bible Church as co-pastor and as an instructor at Rhema Bible Training College. The same official biography states that she has served on staff since 1993 in multiple ministry roles. Don Burns is publicly presented by McGraw Realtors as a Tulsa-area team lead and REALTOR. Those documented public roles belong to the parents; they do not establish that Trevor holds a role at Rhema, McGraw Realtors, or any related organization.

## Public profile, affiliations, and social-connection review

The research located a limited public profile for Trevor Burns compared with the public footprint of his parents and brother. A few publicly indexed social-media posts include or tag a Trevor Burns in the Hagin/Burns/Rhema network. Because social platforms permit duplicate names, incomplete profiles, tagging by third parties, and changing account handles, this report does not treat those references alone as verified identity, personal views, employment, income, business affiliation, or close friendship.

### Education and school-athletics record

A MaxPreps athlete profile identifies Trevor Burns with Metro Christian High School in Tulsa, Oklahoma. The profile lists varsity basketball and varsity football participation and includes Metro Christian career-history entries. This is a documented school-athletics affiliation for the individual profiled. The page does not publish parent names, a diploma, a graduation date, college enrollment, degree history, Rhema Bible Training College attendance, trade credentials, or a professional license. Metro Christian’s 2025 graduation ceremony was listed for May 22, 2025 at Asbury Church in Tulsa, but the event page does not include a graduate roster. Accordingly, this report does not state that Trevor graduated from Metro Christian without an official school announcement, ceremony program, class list, diploma, or direct confirmation.

### Employment verification finding

Finding: No reliable public source located in this review verifies that Trevor Burns is employed by Rhema Bible Church, Kenneth Hagin Ministries, Rhema Bible Training College, or The Burns Home Team. This negative result is not proof that he has never performed work for any organization; private employers do not have to publish a full staff roster. A public website should not state an employment claim unless it is supported by an official staff listing, job announcement, direct statement, lawful employment record, court filing, or reliable contemporaneous reporting.

### Publicly defensible website wording

“Public sources confirm Trevor Burns’s family relationship to Don Burns and Rev. Denise Hagin Burns, and historic ministry records identify him as a great-grandson of Kenneth E. and Oretha Hagin. A MaxPreps athlete profile identifies Trevor Burns with Metro Christian High School in Tulsa and lists basketball and football participation. The reviewed public record does not verify a current Rhema job title, ministry office, graduation, postsecondary education credential, business ownership interest, salary, or political role.”

## Financial interests, compensation, travel, politics, and legal-record limits

This section separates questions that are reasonable to ask in public-interest research from claims that the currently available public record cannot support. Trevor Burns is not identified in the reviewed sources as a public officer of a ministry or charity. Financial and banking details are generally private unless disclosed in a filing, litigation, public contract, campaign report, or an individual's own verified statement.

### Why family context is not a financial finding

The Hagin/Burns family's public association with Rhema and related ministry institutions provides historical context. It does not establish that Trevor has access to organizational funds, receives compensation, benefits from church assets, participates in governance, or has knowledge of institutional decisions. A claim about any transaction would require records that identify the payer, payee, purpose, amount, date, and authorizing authority.

## Research cautions, records needed, and source notes

### Records that would resolve unanswered questions

- Official staff directory, job posting, written confirmation, or lawfully available employment documentation to confirm or disprove a Rhema, KHM, RBTC, or family-business employment claim.

- An official Metro Christian graduation roster or ceremony program, diploma, direct school confirmation, authorized postsecondary verification, university/college bio, professional license listing, or Trevor Burns's own verified public biography to confirm graduation, college, vocational, or credential claims beyond the documented athletics profile.
- Oklahoma Secretary of State entity records, annual certificates, registered-agent filings, or public business registrations if a specific ownership interest is alleged.
- Publicly available campaign-finance or lobbying disclosures if a political contribution, campaign role, committee relationship, or lobbying activity is alleged.
- A sponsorship agreement, invoice, board approval, expense reimbursement, conflict-of-interest disclosure, public contract, or reliable investigative reporting that identifies a specific transaction, if organizational funding or personal benefit is alleged.
- Court docket, agency order, or reliable reporting with conservative identity matching before publishing any legal or disciplinary claim.

### Research cautions and non-inference rules

- Family relationship is not proof of employment, ministry authority, salary, access to assets, political alignment, knowledge, or responsibility for a relative's conduct.
- A social-media tag, photo, comment, follow, or event appearance is evidence of a visible connection at a point in time; it is not proof of a paid relationship, business partnership, or private agreement.
- Other people named Trevor Burns appear in public education, sports, real-estate, and professional search results. The Metro Christian MaxPreps athlete profile is included because it matches the Tulsa-area school context, but it should not be used to claim graduation, college attendance, employment, or financial information without additional corroboration.
- No claim about a church, ministry, charity, or family business funding Trevor Burns should be published without documentation that identifies the transaction and the funding entity.
- A lack of public financial records is not evidence of hidden assets or wrongdoing.
