These are significant claims, and if true, they raise profound questions about governance, leadership, and accountability. They should be evaluated carefully, fairly, and based on evidence.

If leaders possessed credible information for years, members deserve honest answers.

If ministers publicly denied knowledge while privately possessing relevant information, that raises ethical concerns about transparency and stewardship.

The questions extend beyond one family or one ministry:

When leaders become aware of concerning behavior involving another leader, what is their ethical responsibility?

What safeguards existed to protect those who may have been affected?

Were allegations appropriately documented, investigated, and addressed?

Were boards and governing bodies informed?

Were members given truthful information, or were important facts withheld?

What policies were in place to prevent conflicts of interest when family members held positions of authority?

Trust is built through honesty—not image management.

Scripture repeatedly calls leaders to a higher standard of integrity. The biblical expectation is not perfection but truthfulness, humility, repentance, and accountability. When leaders speak from the pulpit, congregations reasonably expect that what they are being told is truthful to the best of those leaders' knowledge.

Accountability is not an attack on the Church. It is one of the ways healthy organizations preserve trust and protect people.

As advocates, our responsibility is to distinguish verified facts from allegations, encourage careful documentation, and ask questions that help establish the truth. The goal should never be to spread rumors, but neither should concerns be dismissed without thoughtful examination.

Healthy institutions do not fear honest questions.

They answer them.

John MacArthur has spent decades teaching that God hates abuse. He has said husbands are called to love their wives sacrificially, not dominate them. On paper, that sounds exactly right.

But theology isn't only tested by what we say. It's tested by what we do when someone comes to us for help.

In the early 2000s, a woman named Eileen Gray left her husband after reporting years of abuse, both to the church and eventually legal authorities.

Rather than being publicly supported, she was placed under church discipline at Grace Community Church, where John MacArthur told the entire congregation that she had refused the elders' counsel because she refused to reconcile with her abuser and was to be treated as an unbeliever unless she repented, citing Matthew 18:17.

"...follow the mandate of Matthew 17 verse 17."

Meanwhile, her husband, David Gray, would later be convicted of multiple crimes involving the abuse of children and child molestation. He received a very lengthy prison sentence.

Years later, even a former elder at Grace Community Church concluded the church had handled Eileen's case wrongly and urged the leadership to make it right. According to his account, those efforts were rejected. John MacArthur repeatedly refused to reconsider the church's handling of Eileen's case.

This isn't about celebrating someone's mistakes or attacking a person. It's about asking a hard question:

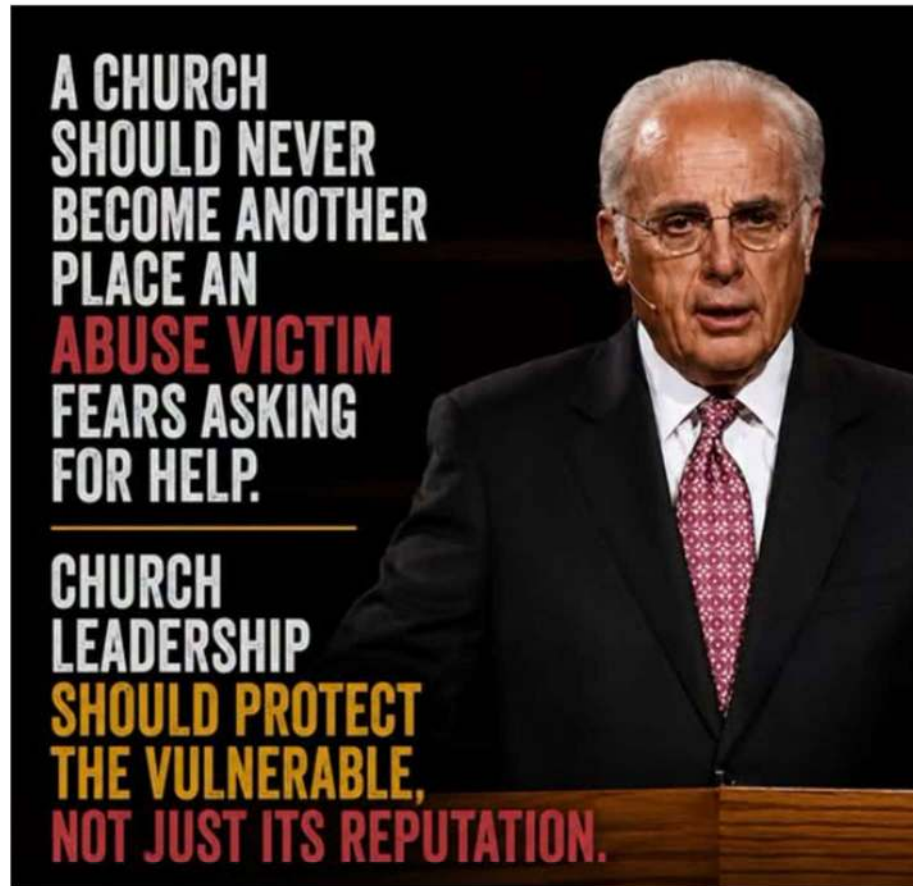
What message does it send to abuse victims when the person seeking safety is very PUBLICLY disciplined, while history ultimately confirms that the danger they were warning about was real?

What kind of leadership hears a woman plead for protection, publicly shames her for leaving, and then never publicly makes it right even after the truth comes to light? That isn't courageous leadership. It's leadership that protects its own authority and reputation more fiercely than the vulnerable entrusted to its care.

Churches should be the safest place for the vulnerable, not another place where victims learn that speaking up may cost them their church family while the person harming them is given the benefit of the doubt.

When leaders get something this serious wrong, humility should compel repentance just as quickly as they expected repentance from the victim.

If our theology cannot recognize abuse when it stands before us, then perhaps it isn't the victim who needs correcting. Perhaps it's our application of Scripture.

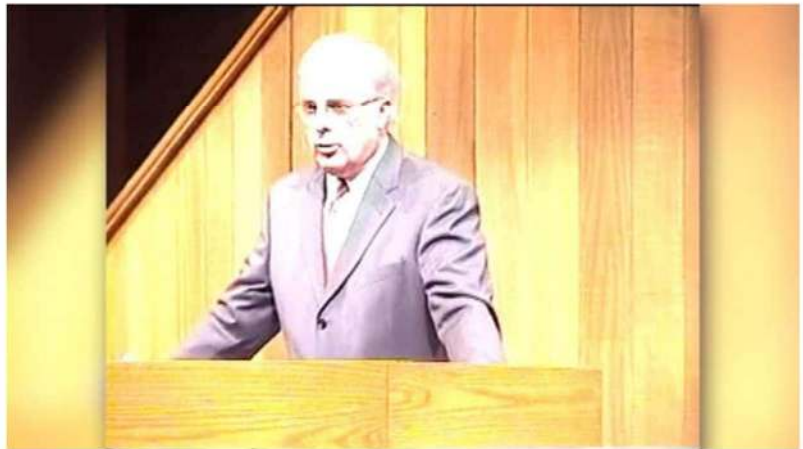

EXCLUSIVE: John MacArthur Shamed, Excommunicated Mother for Refusing to Take Back Child Abuser

On August 18, 2002, prominent radio pastor and author, John MacArthur, took time during an evening service to address a grave matter at his 8,000-member Grace Community Church (GCC) in Sun Valley, California.

A woman at GCC was living in sin, MacArthur alleged. And though shaming her publicly was "sad," MacArthur said it was necessary to maintain fidelity to God and His Word.

He also urged the church to pray for her husband, David Gray, who taught music and Bible to children at Grace Community Church (GCC) from 1994 to 2001. "Pray for David, for the sympathy and compassion and the lovingkindness of God to be his portion."

MacArthur then invited the church to sing, "Amazing Grace."

Today, David Gray is serving 21 years to life in a California prison for his 2005 convictions for aggravated child molestation, corporal injury to a child, and child abuse.

But at the time of Eileen's shaming, Eileen had not yet reported her husband's physical and mental abuse to police. (She was not yet aware of his sexual abuse.)

Instead, she had reported the abuse to elders and pastors at GCC.

Eileen also had not left her husband. In August 2002, Eileen was still living with her children in the Grays' home about 1.5 miles from the church.

Eileen had, however, filed legal separation and restraining orders against David due to his repeated abuse of her and her children, as well as his alleged stalking and threats to kill them and himself. At the time of the shaming, Eileen had obtained a court order requiring that David's visits with the children be monitored and restricting him from coming within 100 yards of Eileen.

As Eileen explained in an exclusive interview with *The Roys Report*, she went to GCC elders, hoping they would protect her and her children and get David professional help.

Instead, she says the church subjected her to spiritually abusive counseling and used church discipline to try and coerce her to take David back into the family's home.

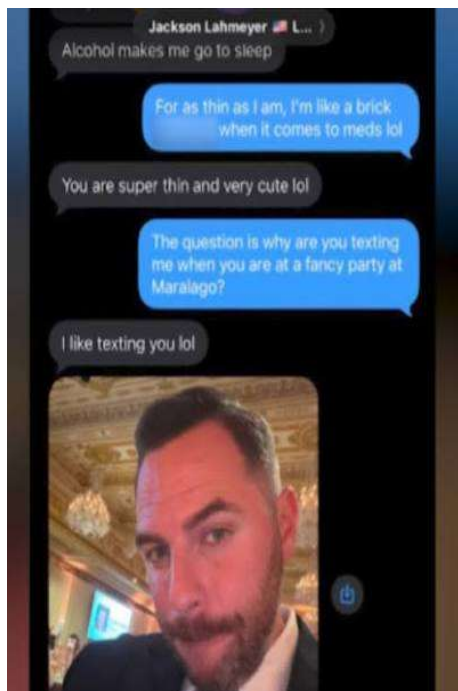

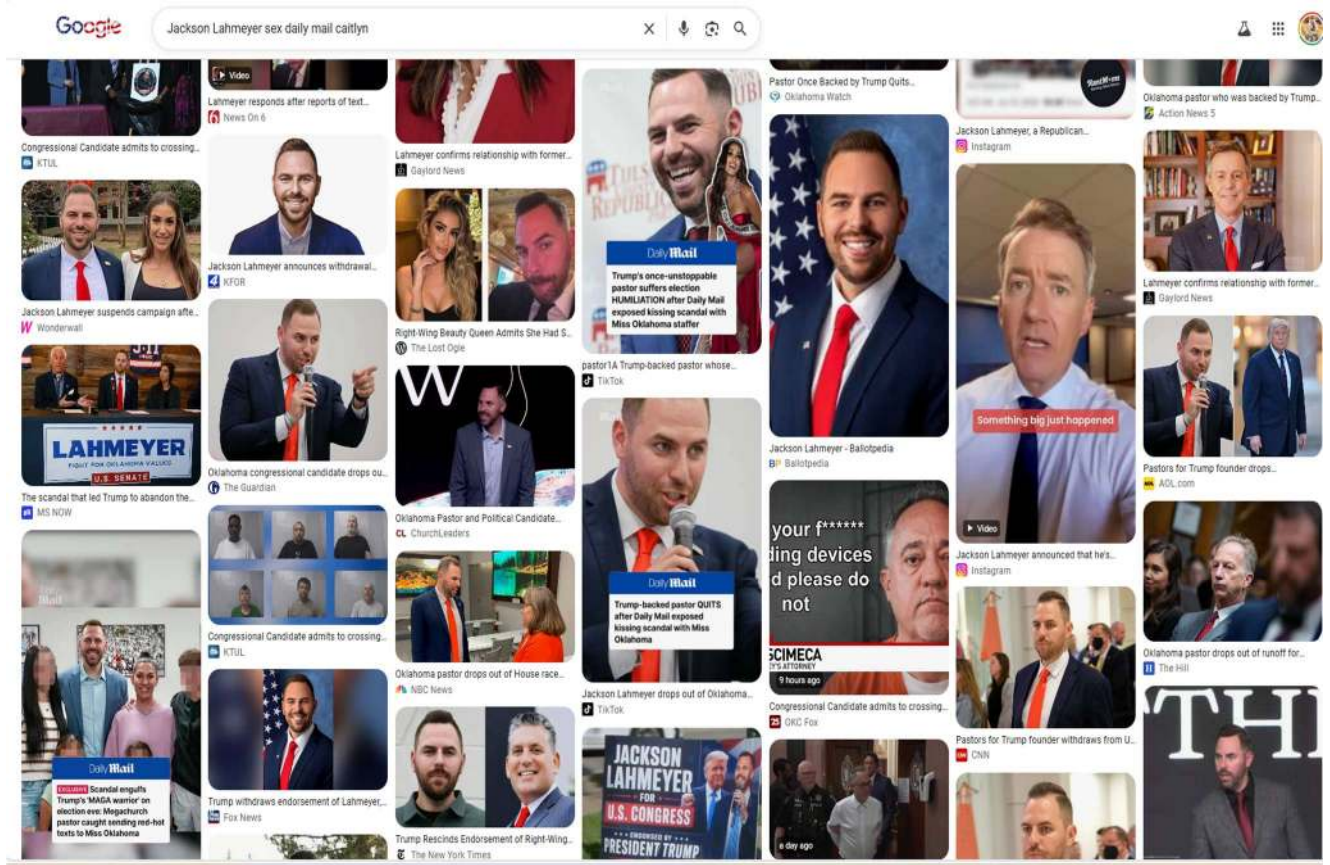

Jerry and I both are so excited and thankful that Pastor Jackson was able to spend a couple of days with some of the precious people we love so much.

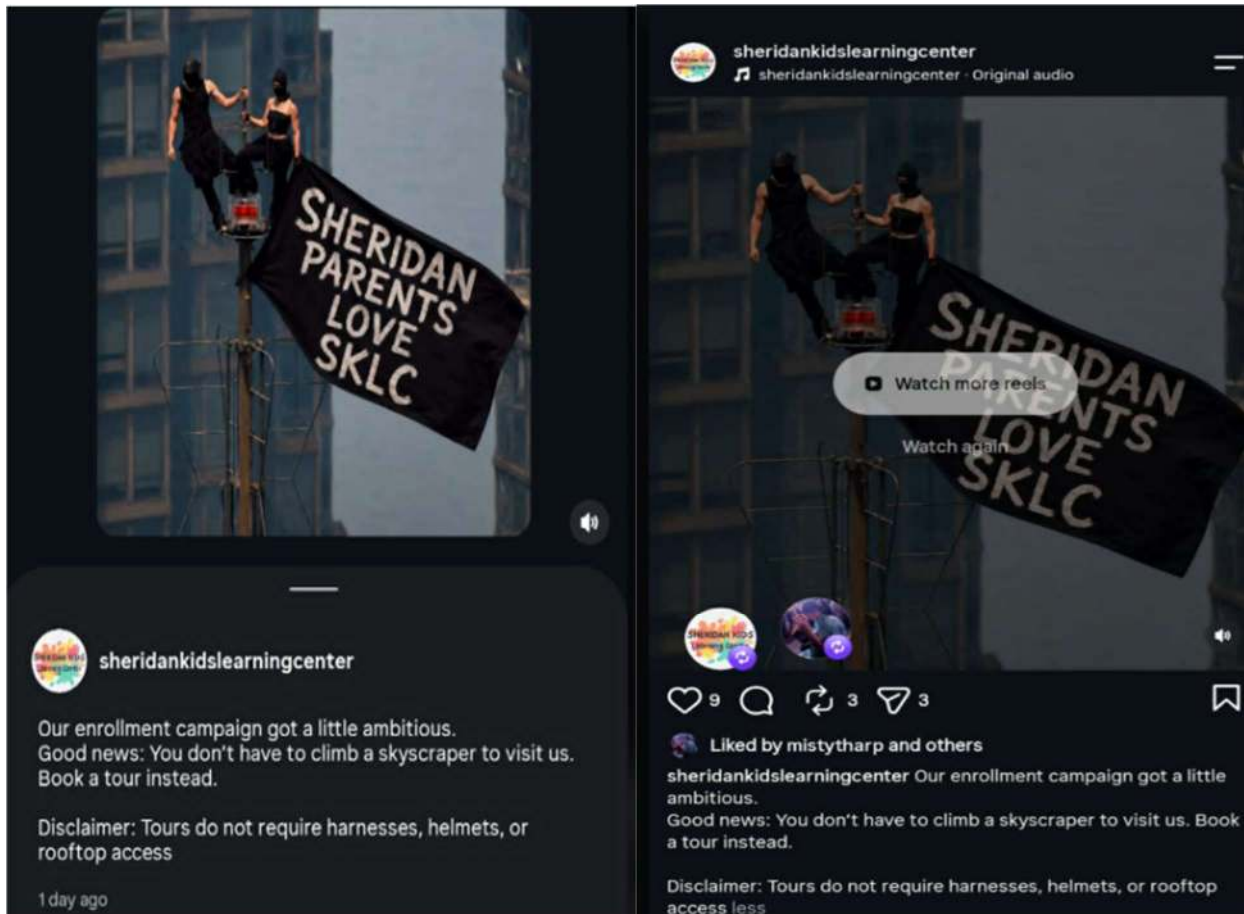

Parents: Ask Questions Before You Entrust Someone With Your Child**

Every parent and grandparent has both the privilege and the responsibility of carefully evaluating the environments where children will spend their time.

When concerns about any organization—whether a school, daycare, church, sports program, or youth organization—become public, it is reasonable to ask questions and seek information before making decisions.

Children deserve environments that prioritize: Safety above reputation. Transparency above secrecy. Accountability above loyalty to individuals. Clear safeguarding policies. Thorough background screening. Mandatory reporting of suspected abuse. Independent oversight when concerns arise. A culture where parents' questions are welcomed rather than discouraged.

As parents and grandparents, we are our children's first line of protection. Due diligence is not fear—it is responsible stewardship. Before enrolling a child anywhere, consider asking:

What are your child protection policies? How are allegations handled? Is there independent oversight? What training do staff receive on abuse prevention and mandatory reporting? How are complaints documented and investigated? Can parents review your safety policies? How many complaints have been made against this facility?

Every organization should be willing to answer these questions openly. Our responsibility is not to assume guilt or innocence based on headlines. Our responsibility is to gather information, think critically, and place children in environments that demonstrate a genuine commitment to safety, integrity, and accountability.

Children deserve nothing less.

What If We Are the Problem? The Church doesn't exist in isolation.

We raise children. We teach. We disciple. We mentor. We model what integrity, leadership, and character are supposed to look like. Then we send those people into the world.

They become our political leaders. Our physicians and nurses.

Our educators. Our police officers. Our judges. Our attorneys. Our daycare workers. Our business owners. Our influencers. Our pastors. Our nonprofit leaders. Our parents.

If we normalize silence, they normalize silence. If we excuse corruption, they excuse corruption. If we protect power over people, they protect power over people. If we refuse accountability, they refuse accountability.

Culture doesn't suddenly become corrupt. It is shaped—one generation at a time—by what we tolerate, celebrate, ignore, and reward. It can look polished. It can sound spiritual. It can have beautiful worship, impressive buildings, and charismatic leaders.

But do you feel the ick?

That uncomfortable feeling when something doesn't align with truth... when image matters more than integrity... when protecting institutions becomes more important than protecting people.

What if the crisis we see in our culture isn't only outside the Church? What if accountability begins with us? Not with "those people." Not with the government. Not with Hollywood. Not with the schools. With us.

Repentance has always started with God's people. Accountability is not an attack on the Church—it is an act of love for the Church. Because every time corruption goes unchecked, more people are harmed, trust is eroded, and another generation learns that appearance matters more than character.

The question isn't whether the world needs changing. The question is whether we are willing to let God change us first.

Ted Shuttlesworth Jr., a Florida-based Pentecostal pastor and evangelist, says he is stepping away from ministry after admitting he engaged in sexual activity outside his marriage, according to letters shared with supporters.

Shuttlesworth, co-pastor of [Miracle Word Church](#) in West Palm Beach, acknowledged what he described as moral failure and said he has repented to God and his wife. His decision to step down is temporary, he indicated.

"Unfortunately, in the midst of so many miracles and breakthroughs, I let my own guard down. ... I failed to stand in my authority when temptations came," Shuttlesworth wrote in the letter, which surfaced this week.

"Needless to say," he continued, "my actions opened the door, which I allowed, for sin to come in

NEW RHEMA STATEMENT ON CRAIG HAGIN

RHEMA Bible Church has released a new public statement regarding the termination of Craig Hagin, and FOX23 News is now reporting additional details from church leadership.

According to Kenneth and Lynette Hagin, they were presented with documented evidence that led to Craig Hagin's immediate termination from RHEMA and all affiliated ministries. In their statement, they say previous concerns had been raised, that Craig denied those concerns when confronted, and that they now believe they were deceived.

Among the most significant statements:

- "This was not the first time serious questions about Craig's personal conduct had been raised."
- "We believed our son and we now know that in doing so, we were deceived by him."
- "He was living a life we did not see."
- "What we saw was both shocking and devastating."

FOX23 reports that church leadership described the evidence as reliable and stated that Craig's conduct was inconsistent with the values and standards expected of ministry leadership. While specific details were not disclosed, leadership stated that the evidence revealed a double life they did not know existed.

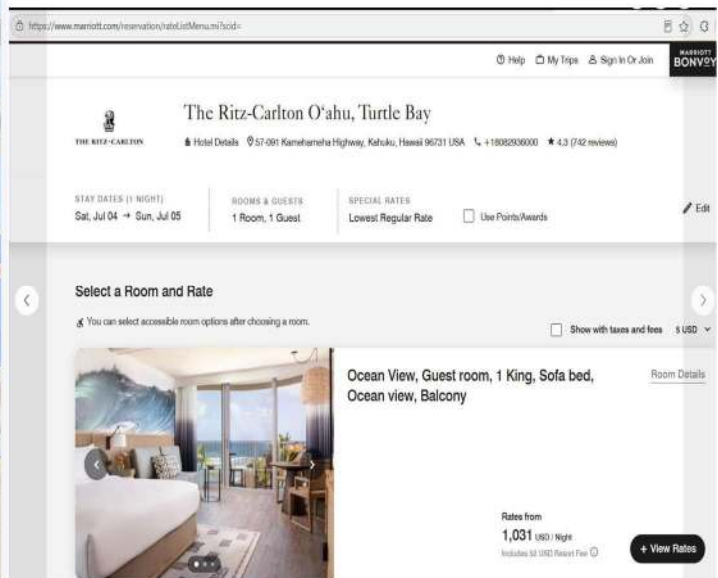
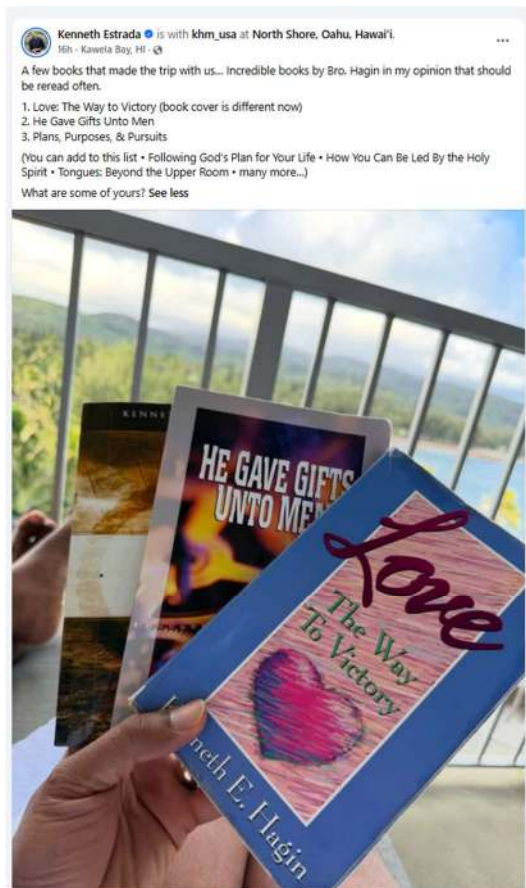

A Question About Stewardship

I recently saw a social media post showing two pastors traveling enjoying what appeared to be a beautiful oceanfront destination. It made me stop and think—not just about them, but about leadership in general.

How are the people they serve doing? Are the families in their congregation able to take a vacation once in a while? Are parents struggling to pay rent or buy groceries? Are children well-fed, clothed, safe, and supported? Are single mothers receiving practical help? Are widows, seniors, and those facing hardship being cared for? Healthy leadership isn't measured by where leaders travel or what they own. It's measured by how faithfully they serve the people entrusted to their care.

Every church has different resources, and there is nothing inherently wrong with taking a vacation or enjoying the fruit of one's work. The more important question is whether a ministry demonstrates faithful stewardship, transparency, and genuine care for its congregation alongside those opportunities.

The New Testament repeatedly calls church leaders to be shepherds who willingly serve the flock—not merely lead it from a distance. That includes modeling humility, exercising

sound stewardship, and ensuring that the needs of vulnerable people are not overlooked. Perhaps the question every church should ask is this:

if someone looked at the lives of our leaders, would they also see a congregation that is flourishing? Because the health of a ministry is reflected not only in its platform, buildings, or influence—but in the well-being of the people it serves.

OKLAHOMA CITIZENS PARTICIPATION ACT (ANTI-SLAPP LAW)
12 O.S. §§ 1430–1440

This act is intended to protect the rights of citizens to engage in freedom of speech, petition, association, and the right of individuals to participate in government and matters of public concern without fear of retaliatory lawsuits. It allows a defendant to file an early motion to dismiss a legal action that is based on, relates to, or is in response to the exercise of these constitutional rights. If granted, the plaintiff may be required to pay the defendant's reasonable attorney fees and costs.

Oklahoma has a strong anti-SLAPP law, the Oklahoma Citizens Participation Act, that protects people, journalists, podcasters, advocates, and citizens who speak on matters of public concern.

The law allows a defendant to file an early motion to dismiss when a lawsuit appears to target protected speech, petitioning, association, or public participation.

If the court agrees the claims arise from protected activity and the plaintiff cannot meet the required burden, the case may be dismissed early.

This matters when people are reporting, questioning, documenting, or advocating about issues of public concern, including institutional accountability, public leadership, child safety, religious leadership, governance, and community harm.

When a court grants an Oklahoma anti-SLAPP motion, fees and costs may be awarded, and sanctions may also be available depending on the court's findings.

The law is designed to reduce the chilling effect of lawsuits aimed at silencing lawful public participation.

Oklahoma's anti-SLAPP law is the **Oklahoma Citizens Participation Act**, codified at **12 O.S. §§ 1430–1440**. Its purpose is to protect free speech, petition, association, and public participation while still allowing valid lawsuits for real injury. **2025 Oklahoma Statutes Title 12. Civil Procedure §12-1430. Short title - Oklahoma Citizens Participation Act.**

Universal Citation:

12 OK Stat § 1430 (2025)

A. This act may be known and shall be cited as the "Oklahoma Citizens Participation Act".

B. The purpose of the Oklahoma Citizens Participation Act is to encourage and safeguard the constitutional rights of persons to petition, speak freely, associate freely and otherwise participate in government to the maximum extent permitted by law and, at the same time, protect the rights of a person to file meritorious lawsuits for demonstrable injury.

My REPLY

I agree that Scripture takes the condition of the heart seriously. Jesus made it clear that hatred, bitterness, and malice are sins that require repentance. At the same time, it's important to distinguish between hatred and accountability.

The Bible also teaches that truth, justice, and correction are essential parts of a healthy community. Confronting misconduct, reporting abuse, exposing corruption, or asking leaders difficult questions is not the same as harboring hatred toward them. In fact, throughout Scripture, God repeatedly raised up prophets and faithful individuals to confront wrongdoing.

Nathan confronted David.

Elijah confronted Ahab.

John the Baptist confronted Herod.

Paul publicly corrected Peter when his conduct compromised the gospel.

None of those actions were motivated by a desire to destroy people; they were motivated by a desire to restore righteousness, protect others, and honor God.

There is an important difference between:

- Slander and truthful reporting.
- False accusations and documented evidence.
- Revenge and accountability.
- Character assassination and legitimate public concern.
- Hatred and seeking justice for those who have been harmed.

If someone knowingly spreads lies to destroy another person, that is sinful. But if credible evidence exists that leaders have abused power, covered up misconduct, intimidated witnesses, or failed to protect vulnerable people, Christians should not remain silent. Silence can enable further harm.

Scripture repeatedly commands believers to defend the oppressed, establish justice, expose the works of darkness, and protect those who cannot protect themselves. Accountability is not the enemy of the Church—it is one of the ways God preserves its integrity.

The goal should never be to destroy people. The goal should be truth, repentance where necessary, restoration when possible, justice for victims, protection of the vulnerable, and integrity within Christ's Church.

Eugene Gregory Update

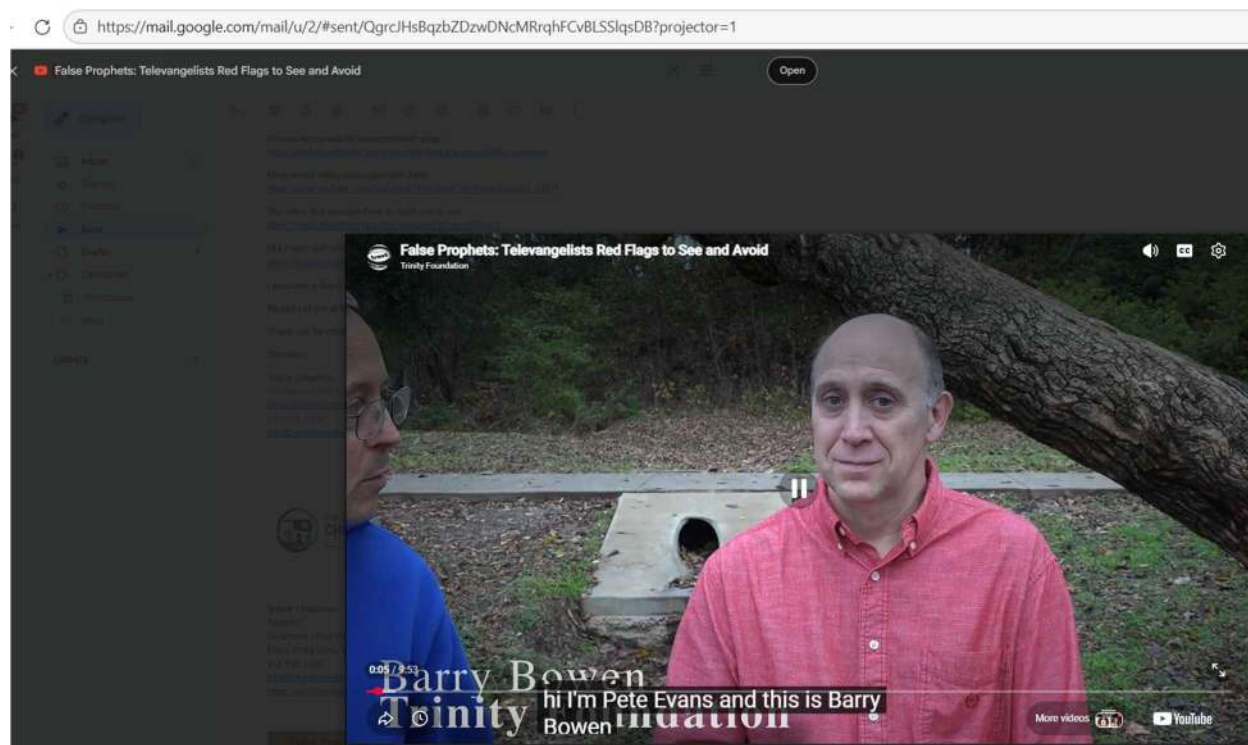

When the Sermon Produces Comments Like This...

Take a moment to look at the responses.

"Financial breakthrough."

"Financial miracle."

"Heaven's bank is open."

"Wealth floods my life."

"I am wealthy."

The overwhelming takeaway isn't repentance, discipleship, loving your neighbor, serving the poor, forgiving your enemies, caring for widows and orphans, pursuing holiness, or becoming more like Christ.

Instead, the dominant expectation is: **"I'm about to get money."**

That should cause every pastor, elder, Bible teacher, and Christian to pause.

Jesus spoke far more about the condition of the heart than the condition of our bank account. He called people to deny themselves, take up their cross, seek first the Kingdom of God, and faithfully steward what they had. The apostles preached repentance, holiness, generosity, endurance through suffering, and faithfulness—not formulas for financial increase.

God certainly blesses His people, and Scripture teaches that He provides for our needs. But there is an important difference between trusting God as our Provider and treating Him as a mechanism for prosperity.

A healthy sermon should produce transformed hearts, not simply heightened financial expectations.

It's worth asking:

- Are people leaving with a deeper understanding of Christ?
- Are they more committed to loving God and loving others?

- Are they challenged to grow in humility, integrity, generosity, and obedience?
- Or are they primarily expecting a financial windfall?

The fruit of a message often reveals what was actually emphasized.

If nearly every response centers on receiving wealth, perhaps the greatest takeaway wasn't the Gospel—it was the promise of prosperity.

As believers, we should never measure the success of a sermon by how excited people become about money. We should measure it by whether it produces lives that increasingly reflect the character of Christ.
