

Skylar E. Hagin and Immediate Family

Public-Source Leadership, Ministry, and Record Review

Purpose and scope

This report compiles publicly available organizational materials, media reporting, and public social-media posts relevant to Skylar E. Hagin and the publicly identified parent relationships requested for review.

It distinguishes documented facts from unverified claims. It does not infer responsibility, knowledge, or misconduct by one family member from another person's conduct or legal matter.

Research status: Public-source review only; not a criminal-background check, legal opinion, or exhaustive records search.

Key findings

Skylar E. Hagin	Official 2025 Rhema event material identifies him as a Rhema Bible Training College graduate (studies completed in 2022 and 2023), a speaker at Summer Blitz 2025, the overseer of Rhema Christmas Lights, and a traveler with Kenneth and Lynette Hagin for Living Faith Conferences.
Public parent references	Craig Hagin publicly described Skylar as his youngest son. A public account using the name Missy Pittman publicly referred to Skylar as her son. The reviewed sources did not independently verify every prior name or legal relationship listed in the request.
Current public concern affecting family context	Craig Hagin is not Rhema's current COO. Rhema states that his employment, leadership roles, and authority to speak or act for Rhema ended effective June 3, 2026. The church states a criminal matter remains pending and says it received documented information about conduct inconsistent with leadership standards.
Records review result	No reliable public reporting or official court source located in this review linked Skylar E. Hagin personally to an arrest, charge, criminal conviction, professional discipline, or civil judgment. This is not proof that no record exists.

1. Family-relationship documentation

The requested family identifiers require care because public records and social posts do not all function as official genealogical documentation. The findings below reflect what the sources actually establish.

Skylar and Craig Hagin

Craig Hagin's public social-media post referred to Skylar E. Hagin as his "youngest son." Separately, a 2008 Kenneth Hagin Ministries publication identified Skylar among Kenneth W. and Lynette Hagin's five grandsons. Together, those materials support the documented relationship of Skylar as Craig Hagin's son and as a great-grandson of Kenneth E. Hagin.

Skylar and Missy Pittman / Melissa names

A public Instagram account under the name *Missy Pittman* referred to Skylar Hagin as her son. Search results also associate that account with real-estate work in Tulsa. This review did not locate an official public biography, court filing, or government record that independently establishes the requested sequence of names "Melissa Lynn Robertson," "Melissa Hagin," "Melissa Hagin-Pittman," and "Missy Pittman" as one person. Accordingly, the report uses the public identifier "Missy Pittman" when describing those social-media posts and does not state unverified legal-name history as fact.

Important distinction

A family relationship is not evidence of joint responsibility. This report does not assign Skylar or Missy Pittman responsibility for Craig Hagin's conduct, church employment status, criminal case, or other allegations unless a reliable source specifically establishes an individual connection.

2. Skylar E. Hagin: ministry, education, and public activity

Official Rhema material for Summer Blitz 2025 states that Skylar completed studies at Rhema Bible Training College in 2022 and 2023, was scheduled to speak at the event, oversees the Rhema Christmas Lights project, and travels with Kenneth and Lynette Hagin for Living Faith Conferences. The same brochure describes his stated ministry focus as reaching the next generation with "the Spirit of Faith and the power of the Holy Spirit."

Rhema's public social-media channels also featured Skylar preaching in 2026, including a message focused on "walking in love." A public video listing also identified him as a guest speaker for a bilingual service at Fire to the Nations Church. His public Instagram profile identifies him as a Rhema graduate, husband, and Christian follower.

Verified public-facing roles and engagements

2022-2023	Completed Rhema Bible Training College studies, as described in the Summer Blitz 2025 brochure.
July 2025	Listed as a Summer Blitz 2025 speaker; official event brochure says he oversees Rhema Christmas Lights and travels with Kenneth and Lynette Hagin for Living Faith Conferences.
2025	Public posts by Craig Hagin announced Skylar was ministering at Summer Blitz and later speaking at Living Glory Church in Lafayette, Louisiana.
2026	Kenneth Hagin Ministries public posts promoted Skylar preaching at Rhema and summarized a message about love as evidence of spiritual life.
2026	A public YouTube listing identifies him as a guest speaker for a bilingual church service.

3. Craig Hagin: current leadership status and publicly reported legal matter

The requested description of Craig Hagin as “COO Rhema” is outdated. Public materials before June 2026 described him as a co-pastor, instructor, and chief operating officer. However, Rhema Bible Church now states that Craig’s employment, leadership roles, and authorization to serve, speak, or act on behalf of Rhema and its ministries ended effective June 3, 2026.

Rhema’s statement says Craig was initially placed on sabbatical following charges in a pending criminal matter. In a later message, the church said it was presented with documented information concerning conduct “wholly inconsistent” with its leadership standards, and that it acted immediately after reviewing the information. The church’s statements do not identify the additional alleged conduct in public detail.

Local news reporting states that Craig and his wife, Mia Hagin, were arrested in March 2026 after police and animal services investigated conditions at a south Tulsa residence. Reporting stated that the couple each faced animal-cruelty charges. This report does not presume guilt. The charge status should be checked directly through current court records before publication of any updated claim.

Why this belongs in a family-context report

Craig Hagin's former senior leadership role and the public nature of his removal from Rhema affect the organizational context around a close family member who is publicly ministering in the same ministry network.

It does not establish misconduct by Skylar, Missy Pittman, or any other family member.

4. Missy Pittman / public professional profile

The public Missy Pittman Facebook and Instagram profiles identify a Tulsa-area real-estate profession, including “Realtor Associate” with Chinowth & Cohen Realtors. The reviewed public posts include family and real-estate content. This review did not identify a reliable award, license-discipline finding, lawsuit, arrest, or criminal charge tied to Missy Pittman from the sources examined.

The absence of a result in this public web review is not an official license check. A formal professional review would require confirming the individual’s exact license identity and checking the Oklahoma Real Estate Commission’s current disciplinary and license records.

5. Credibility indicators, concerns, and limits

Credibility indicators	Skylar has documented Rhema training, recurring speaking opportunities, an identified operational role overseeing a large annual public event, and official ministry promotion of his messages. Missy Pittman has a public professional real-estate profile.
Concerns appropriate for public accountability review	Skylar’s ministry activity occurs within a closely connected organizational network where his father was recently terminated from senior leadership amid a pending criminal matter and separately described “documented information” about conduct inconsistent with leadership standards. The appropriate question is organizational governance and safeguarding - not inherited blame.
What was not found	No reliable source located in this review connected Skylar personally to criminal charges, court sanctions, civil claims, professional discipline, or a documented misconduct allegation. No independently verified awards were located for Skylar or Missy Pittman.
What should not be claimed	Do not state that Skylar was involved in, knew of, benefited from, or covered up any conduct by Craig Hagin without independently verifiable evidence. Do not represent social-media material as a legal record.

6. Accountability questions for an organization

1. What written conflict-of-interest, supervision, credentialing, and safeguarding standards govern ministry roles held by relatives of senior leaders?
2. What due-diligence steps, disclosures, and accountability structures apply to emerging ministers who travel with the organization or speak to youth audiences?
3. How does Rhema distinguish family lineage from demonstrated readiness, independent oversight, and transparent leadership qualification?
4. After the June 2026 leadership termination, what governance changes, independent reviews, or reporting channels are in place to protect congregants, students, employees, volunteers, and ministry participants?
5. What current personnel or ministry roles does Skylar hold, and what supervision or reporting structure applies to those roles?

These are governance and transparency questions. They should be answered with current policies, records, and organizational statements rather than inference or family association.
